**ISSUE OF FULLY PAID SHARES – SECONDARY TRADING NOTICE  
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001  
("Act")**

On 23 September 2004, the Company announced the proposed issue of 7,500,000 fully paid ordinary shares at 40 cents per share to raise \$3,000,000.

These shares were issued on 1 October 2004 and an Appendix 3B is attached.

**Secondary Trading Exemption**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. A sale of the shares noted above will fall within the exemption in section 708A(5) of the Act.

The Company hereby notifies ASX under paragraph 708A(5)(e) of the Act that:

    - A. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - B. the rights and liabilities attaching to the shares.
