## **Board Restructure**

The Board is pleased to announce the appointments of Messrs Sean Llewelyn and Cliff Davis as independent Non Executive Directors of the Company. These appointments are effective immediately.

**Mr Sean Llewelyn**, first qualified as a barrister and solicitor in England and Australia. His life work however has been in finance and merchant banking having worked for more than 20 years in this capacity in Australia, the UK, the USA and South Africa. His considerable experience has been on derivatives, structured finance and early stage investment relating to the metal markets. These have included Rio Tinto,, Kennecott, TVX Gold Inc., Echo Bay Mines Ltd., and Gabriel Resources.

He is based in Toronto and is currently a director of Tiberon Minerals Ltd, Rio Narcea Gold Mines Ltd and DRC Resources Corporation, all listed on the Toronto Stock Exchange.

The extensive appropriate experience of Mr Llewelyn and Mr Davis significantly strengthens the Board and they will no doubt prove invaluable to the development and advancement of Paladin in this exciting stage of its growth.
