### First Supplementary Bidder's Statement

#### 1 Introduction

This document is a supplementary bidder's statement under section 643 of the *Corporations Act 2001* (Cth). It is the first supplementary bidder's statement (**First Supplementary Bidder's Statement**) issued by Paladin Resources Ltd ABN 47 061 681 098 (**Paladin**) in relation to its off-market takeover bid for all the fully paid ordinary shares in Summit Resources Limited ABN 86 009 474 775 (**Summit**).

This First Supplementary Bidder's Statement supplements, and should be read together with, Paladin's bidder's statement dated 27 February 2007 (**Bidder's Statement**).

# 2 Amendments to Bidder's Statement prior to dispatch to Summit shareholders

Paladin wishes to advise that following the light aircraft accident in Malawi (as announced on ASX on 9 March 2007), ASIC has granted relief for Paladin to amend its Bidder's Statement lodged with ASIC on 27 February 2007 so that the Bidder's Statement to be dispatched to shareholders shortly will reflect the tragic loss of Mr Garnet Halliday, Paladin's Executive General Manager for Operations and Development. This has been achieved by the omission of section 2.3(b)(1) from the original Bidder's Statement (and associated section renumbering).

#### 3 Other notices

Unless the context otherwise requires, terms defined in the Bidder's Statement have the same meaning in this First Supplementary Bidder's Statement.

A copy of this First Supplementary Bidder's Statement has been lodged with ASIC. Neither ASIC nor any of its officers take any responsibility for its contents.
