## **Exciting Entry into the Uranium Market for Clean TeQ**

Clean TeQ Holdings Limited (ASX; CLQ), an Australian technology company in resource recovery and air and water purification, today announced that the Company has entered into an agreement to construct a Clean-iX® Resin-In-Pulp Pilot Plant at the Langer Heinrich uranium mine in Namibia owned by Paladin Energy.

'This Pilot Plant will demonstrate the Clean-iX® Resin-In-Pulp (cRIP) technology for uranium extraction. This technology has been developed to deliver improved returns from a uranium resource and reduce the environmental impact of processing plants,' Clean TeQ's Chief Executive Officer, Greg Toll, said.

'This is an exciting development as it is the first agreement entered into by Clean TeQ in the uranium mining industry. It provides the next stage of development of the Clean-iX® technology and enhances our credibility in the uranium sector and recognises Clean TeQ's expertise in this high growth industry. The agreement is also further evidence of the ongoing developments that we are achieving in our resource recovery division,' said Mr Toll.
