BOARD CHANGES & CHANGE OF REGISTERED OFFICE FOLLOWING PALADIN TAKEOVER

PERTH, Western Australia: Fusion Resources Limited (**Fusion** or **Company**) (**ASX: FSN, TSX: FNS**) is pleased to announce that following Paladin Energy Ltd (**Paladin**) declaring its takeover offer for the Company unconditional, Messrs Rick Crabb, John Borshoff and Ms Gillian Swaby have been appointed as Directors of the Company.
