Takeover bid by Paladin Energy Ltd for NGM Resources Limited – Allotment of Shares

We refer to Paladin Energy Limited's (**Paladin**) off-market takeover bid for all of the fully paid ordinary shares in NGM Resources Limited (**NGM**) which closed at 5.00pm (WST) on 5 November 2010. The compulsory acquisition period is now complete and we can advise that, further to the Appendix 3B dated 9 September 2010, a final allotment was made on 10 December 2010 of 222,234 fully paid ordinary shares in Paladin.

The total number of shares allotted in respect of the off-market takeover bid for NGM is 7,116,001.

The total number and class of all securities listed on the ASX (including the securities above) is 725,579,320.
